## 1. Non-Refundable Deposit, Purchase Price, Fees

3.	Seller's Representations and Warranties	
(a)	The dog is being sold as a companion pet.	
(b)	The dog is being sold free and clear of any lien, security interest, charge or other encumbrance.	
(c)	Seller guarantees that the Dog is a purebred Papillon, kept and raised in my home.	
(d)	The Dog will be up-to-date on required vaccinations (unless otherwise discussed/noted) at the time of sale. The dog will include a well check examination by a licensed veterinarian and full disclosure from the Seller if any known health concerns are present at the time of sale. Seller will in no way be responsible for any and all heal problems that may arise including internal, external, skeletal, hereditary, breed specific problems and any other health related problems. Buyer has (7) days from the delivery/pickup date to have the Dog examined by a license veterinarian, at Buyer's sole cost. If the Dog fails the examination due to a major health issue, Buyer may return the Dog, with a written statement from the veterinarian of diagnosed health issue, for a full purchase price references and any other properties of the problems.	th r nsed rn fund
	or puppy replacement, if available. Failure by Buyer to have the Dog examined within the (7) day period will this warranty and no refund will be given. If Buyer chooses to keep the puppy, no replacement will be given a medical costs and treatment are sole responsibility of the Buyer.	

(e) Seller will take the Dog back at any time during the Dog's lifetime for any reason. Seller will not issue a refund or

provide another Dog to Buyer.

#### 4. Fitness of Purpose

The Dog was bred as a companion animal, and Seller does not provide any warranty as to the Dog's fitness for any specific purpose, including obedience trials, show ring performance, and/or breeding purposes.

#### 5. Buyer's Representations

Buyer represents to Seller that:

- (a) The buyer understands the Dog is being represented and sold as a companion pet only, which means

  Buyer understands that the dog is being sold "as is" including health, temperament, and house manners.
- (b) Buyer will not keep the Dog chained or tethered for an extended period of time or permanently house the dog in a kennel.
- (c) Buyer will provide the Dog with nutritious food and necessary veterinary care, including de-worming, heartworm prevention and regular vaccinations (including rabies).
- (d) Buyer is not acting as agent for any other person or business in the purchase of the Dog.
- (e) Buyer will not sell, give, or release the Dog to a pet shop, retail store, dog dealer, animal testing facility, research facility, or an agent for any such business or facility.
- (f) Buyer agrees that they have thoroughly researched the Papillon breed and understands the time, love, cost and commitment needed to properly care for their new family member.
- (g) Buyer is aware this contract covers only the original Buyer and is not transferable.

#### 6. Indemnity and Release

If any action or failure to act on the part of Buyer shall result in any claim, suit, loss, damage, injury, death, or liability, Buyer agrees to defend, indemnify, and hold Seller harmless and to pay all of Seller's costs and exp enses, including reasonable legal fees, any amount paid in settlement and any award or judgment with respect thereof. Buyer releases Seller from any and all liability, costs or damages caused by the Dog after placement with Seller, including but not limited to damage to or destruction of property, and injury to any person.

#### 7. Limitation of Action

Any action or claim brought by Buyer against Seller for breach of this Agreement must be brought within one (1) year of the date such claim or loss occurs.

#### 8. Governing Law

All questions or disputes concerning this Agreement and the exhibits herein will be governed by and construed in accordance with the internal laws of the Commonwealth of Virginia, without giving effect to any choice of law or conflict of law provision or rule (whether of the Commonwealth of Virginia or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the Commonwealth of Virginia.
